Board education consisted of a presentation on the financial sustainability plan for 2018/19. Following the presentation and a discussion, the Board approved the plan.

On the recommendation of the Finance Committee, the Board approved: financial statements for the ten months ending January 31, 2018 and a borrowing resolution for the Thompson General Hospital – HVAC Upgrade – Phase 3 2016/17 Safety & Security Project #3788 valued at \$1,055,784.

#### **Audit Committee Report**

E Kobelka reported on the Committee's work plan item: reappointment of MNP as the Region's auditor has been actioned by means of their previously approved 5-year contract, set to expire after the 2019 fiscal year end.

#### **Governance Committee Report**

On the recommendation of the Governance Committee, the Board approved GP-1 Board Linkage with Other Organizations; GP-2 Board Planning Cycle; GP-3 Cost of Governance; and GP-4 Board & Committee Expenses as presented, with no changes.

#### **Quality, Patient Safety Committee Report**

The committee received the Northern Health Region Indicator Dashboard Monitoring Reports for December 2017 and approved the Quarterly Patient Safety Risk Report for the third quarter as presented.
