POSITION SUMMARY

The Public Health Nurse provides regional support at the sites comprised of the Northern Health Region (NHR) and promotes health based on the Population Health Model within the Region. Responsible for the overall leadership of initiatives, activities, and programs within the assigned Public Health role. This will be achieved through expertise in the six critical program areas of prevention, education, care, management, support and research. Creates interdisciplinary collaborative relationships with fellow health care team members and other community agencies to ensure a high standard of practice and delivery of quality client care.

Guided by NHR Public Health Principles, including Health Equity, Harm Reduction and a commitment to outreach and non-judgmental services, this position will strive to improve the health status of the residents of the Northern Health Region (NHR) working from an advanced understanding and knowledge of Disease Management, harm reduction, population health, determinants of health, and case management delivered within a public health framework. Develops and implements health strategies from a trauma informed care and client centered strength/holistic approach.

The incumbent must fulfill the requirements of the Criminal Records/Vulnerable Person, Child Abuse Registry Check and Adult Abuse Registry Check, and adhere to all NHR policies and procedures.
