The Insight Mentor is an integral multi-disciplinary team member who will support, provide education and information to high risk pregnant women and mothers who are experiencing difficulties with alcohol and/or drugs during pregnancy. Provides direct outreach and advocacy services to women who are at high risk of birthing a child with FAS and their families while maintaining clear interpersonal boundaries with clients.

An empowering, strength based focus and holistic approach will be used. The mentors will work extensively in the community setting.

This position requires the frequent provision of services and travel.
