Working from an advanced understanding and knowledge of Chronic Disease Management, harm reduction, population health, community health development social determinants of health, and case management delivered within a primary health care framework, the Diabetes Educator Dietitian will develop and implement health plans from a client centered strength based/holistic approach.

- Baccalaureate degree in Nutrition or Food Science or equivalent program from recognized University
- Completion of Dietitians of Canada Accredited Dietetic Internship Program

- To be an active Certified Diabetes Educator or to become a Certified Diabetes Educator within two (2) years of employment
- Current certification from a recognized Healthcare Provider Basic Life Support (BLS), or obtain within three (3) months of commencing employment
- Must have a valid Manitoba Class V driver's license and access to a vehicle and willingness to use it to travel in region throughout the year
- Two (2) years (recent) of directly related experience in working with clients with Diabetes or other chronic illnesses preferred
