#### **POSITION SUMMARY**

The Community Dietitian is an integral member of a multi-disciplinary team, who will promote nutrition through population health, community mobilization, and community health development. Creating an interdisciplinary collaborative relationship with fellow health care team members, and other community agencies to ensure a high standard of practice and delivery of quality client care. Guided by Northern Health Region Primary Health Care principles, will strive to improve the health status of the residents of the Northern Health Region (NHR). This will be achieved through his/her expertise in nutrition assessments and clinical based service delivery, health related community action and development, health promotion and education, harm reduction, health protection, social determinants of health, illness and injury prevention, management of chronic illness, clinical services, and research. The Community Dietitian will develop and implement health plans from a client centered strength based/holistic approach.

This position requires some provision of services and travel to outlying communities.
