### POSITION SUMMARY

The Patient Flow Specialist, reporting to the Executive Director Clinical Services, plays a key role in coordinating patient flow and optimizing resource utilization across the Northern Health Region's (NHR) acute care facilities. This role involves facilitating admissions, transfers, repatriations and discharges, while collaborating closely with NHR programs, sites, Service Delivery Organization (SDOs), and Provincial Patient Flow Coordination Center. Supports staff education on admission and discharge planning, delivers presentations on utilization strategies to enhance patient flow, and ensures effective interdisciplinary communication to achieve optimal patient placement. With a focus on regional and provincial initiatives, the specialist drives implementation processes, participates in decision-making to optimize resource use, and supports project planning, data analysis, and quality monitoring. Exercising independent judgment and initiative, the specialist contributes to achieving operational targets and improving patient flow performance while maintaining a regional approach to education, training, and process development.

The position of Patient Flow Specialist functions in a manner consistent with, and supports the mission, vision and values of the NHR.

- Baccalaureate degree in Nursing from a recognized university (combinations of education and experience may be considered)
- Eligible for or possesses current registration with professional body as applicable
- Current certification from a recognized Basic Life Support (BLS) Healthcare Provider, or obtain within three (3) months of commencing employment
